4. Public Participation-

Concerns were expressed predominantly by 2 individuals about the installation of the 5G mast on Black Hill, highlighting health issues and lack of consultation. Other residents expressed concerns that individuals trying to raise a petition about 5G were aggressive in nature, intimidating and making householders feel in a vulnerable position. There were some requests for names to be removed from the petition as they felt they had been coerced into signing. The Chairman explained the petition was nothing to do with the parish council and the parish council is not responsible for the regulations surrounding the installation of the mast.

There have been a lot of positive comments regarding the installation of CCTV. There were members of the public present who asked for clarification of locations and use.

Sarah Wells RVBC partnership officer explained the reasons the Police are driving the project for CCTV installation – Theft, damage to vehicles, ASB, rural and organized crime. She assured everyone that there are regular checks regarding data handling and control and Sabden PC has already registered with the ICO.
